ARTICLES OF INCORPORATION

We, the undersigned, who are citizens of the United States of America, persons of the age of 21 or more, acting as incorporators of a non-profit corporation under the laws of the State of Washington, do hereby certify and adopt the following articles of corporation for such corporation:

FIRST: The name of the corporation shall be **Washington Academy of Knowledge;**

SECOND: The place where the principal office of this corporation shall operate will be the city of Seattle, County of King, state of Washington and the period of its duration is perpetual;

THIRD: The purposes for which the corporation is organized is to provide educational services in order to raise the ability to study and comprehend, the academic understanding and the literacy level of children from primary level to high school level, without regard to race, color, religion, national or ethnic origin, or political beliefs.

FOURTH: The name and addresses of the persons who are the initial trustees of the corporation are as follows:

FIFTH: No part of the net earnings of the corporation shall inure to the benefit of, or be distributeable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Service Code, or the corresponding section of any future tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

SIXTH: Upon dissolution of this corporation, assets shall be distributed for one of more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future tax code, under the supervision of the head of the Parent's Committee of the Washington Academy of Knowledge, or shall be distributed to the Federal Government or to a local or state government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office is then located, exclusively for such purposes or to such organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

SEVENTH: Provision for the regulation of the internal affairs of the corporation are assigned to the Board of Directors to be appointed by the Parent's Committee of the Washington Academy of Knowledge.

EIGHTH: The mailing address of the initial registered office of the corporation is 5801 Phinney Avenue N. #402, Seattle, WA 98103; the name of the initial registered agent at such address is Nicholas L. Anderson.

ARTICLES OF INCORPORATION

NINTH: The initial address of the principal place of business shall be 5801 Phinney Avenue North #402, Seattle, WA 98103.




