PAIN-DRUG-HYPNOSIS PART THREE

There are three distinct parts to be audited, in a PDH. It will run better, more orderly if it is addressed in the order listed below. It is most difficult to get the commands thru the anaten and dubbed in track. When these are run out first, the commands will literally flow out.

1. The anaten. This is the most accessible part of the PDH. Have him go thru it once, uninteruptedly, as full effect. This is an often overlooked factor in any engram running. The running itself is an S-C-S cycle of action, and in order to do it, it is necessary to start at the point that the preclear is at, at the moment the engram is addressed. That point, in PDHes particularly, is, being effect. There is currently such a phobia-fixation on "the preclear must be at cause" that this point is entirely missed. The result is that with much compulsive cause point processing as done today, we are but creating comfortable alter-isnesses; because the process really never began. The verity of the start point has never become real.

The purpose of the "change" is in terms of control over time and space. We gain control over the time by having the preclear scan thru the incident in a certain number of counts. A good way is to find out how long the incident lasted. If it lasted 34 minutes, give him 34 counts, as it fits his time-sense mechanism.

Space control is gained by using beefed up change processing. Have him mockup the PDH environment, in the room, or nearby. Have him be in the room, be in the mockup, be in the incident-- alternatively. As he gets control over this, have him find solids in each, then have him use Ron's latest and best, BE something in each.

2. The stop point for the above will usually be wherein he begins to get dub-in. This will sort of blend, will not be necessarily sharp. This is resultant of some command to "scatter" "Get out of here" or equivalent. Some of the junk that comes in with this phase is often mighty weird. We are still looking at this one, are not certain whether or not the PDHer intalls all of it, or just some of it. As black bodies come most often, it is likely that individual commands have a lot to do with the content. Some have found whole sections of time track imposed. It is only necessary to bring this up to the level of understanding. Run it as effect, then have the preclear mock it up in the time and space of the room reduces this one.

3. With these out of the way, the preclear is now ready to run the PDH as an incident. It will then usually run quite fast and easily. Get each and every command. DO NOT SETTLE FOR ANYTHING LESS THAN A CLEAN, SHARP DROP. If he is in any other time, or in any other space, it will not drop sharply. If it drops, but only lightly or sluggishly, put him back into that time and space wherein it occurred. If what he says produces almost any kind of a needle reaction, particularly, a rise, one or more repetitions will convert it to a drop. It is a good idea to have PC give the command to you, in present time. This puts him at cause point.

A good rule of auditing is that you run those things to which the PC feels he is knowingly being effect of. When this is done, it is not as necessary to do anything for him to be at the start point, as in (1) above.

In the case of PDHs, he is being unknowing effect. So, it is necessary to process him to the status of knowing effect. A "clear" reading is nothing more than an evidence that the PC is not knowingly, or, better, has not keyed in, being compulsively the effect of much of anything, at that moment. That is the ideal time to start him on PDHs. You will know when the needle moves to 2.0-2.25, even sometimes around 1.5 for a female, or 4.0-4.25 the preclear has contacted a PDH, in spite of his ardent denials-- which come mostly in phrases from the incident, itself.

Sometimes another incident will key in at the same time as a PDH. This has happened to me as a preclear, twice. In the very first PDH I contacted, I was in an incident keyed in from reading "The Secret Places of the Lion," by Williamson-- in a tomb in Egypt. In the PDH, the command was given, "This is happening in the year 1234 B.C. in Egypt." It took quite a bit of unravelling to get this one. Just yesterday, I was sitting in a PDH, when a Toleo incident keyed in. Both of these unscrambled nicely, but it took a bit longer. This seems to be the basis of the notion that the PDH itself is dub-in, by those who would rather not confront the PDH. So, don't not-is it, unscramble it

There is nothing which I know of in terms of aberration which is not a direct function of hypnosis. Ron has spoken on this in full detail. Of these, the PDH is the most vicious-- with the exception of the electronic implant.

It constitutes slavery in its lowest degradation. It is minor to enslave the body. It is major to enslave the mind and the spirit. It is even grosser to enslave for the purpose of causing the enslaved to become the enslaver of others. It is a crime of even greater magnitude when this is done to able beings who are seeking help and knowledge; and is committed in betrayal by those they trust. There are many to whom this crime is of such magnitude that it simply cannot be confronted.

Ron has given us a science, which, by its every definition, has for its goal the assisting of man to become more able as a Thetan. He has provided us with the techniques to accomplish this. Is it being accomplished?

The two best indexes of Thetan ability are: the ability to mockup, and the ability to exteriorize. Good processing can but improve these abilities.

You have all had good processing. Has your ability to mockup greatly improved in proportion to the processing you have received? In a spot check, most Scientologists ability to mockup has deteriorated.

About one-half of the populace can exteriorize upon command. With good processing, all Scientologists should be good exteriors, after all of these years... if they have received nothing but good processing. In a spot check, less than half of the Scientologists can exteriorize well.

Is there any real reason that one should feel worse after attending a Congress or a course? The content of same is always enlightening and inspiring, and restimulations would otherwise be relatively minor.

Any of the above constitute an indication that you have been PDHed. Get them run out. Be the person you have mocked yourself up to be at the time you first went into Scientology. That goal is now attainable. All you have to do is run out those PDHes.

And after you, and you, and you have run yours out, what will I do? Nothing more than what I am doing right now. Org is not my dish. But I sure will have a lot of my plowed in buddies back-- then maybe WE can start some new and interesting games on a true third dynamic basis of full granting of beingness one to each and every other, with full games loyalty.

....Sounds interesting? What say then?

Was just reminded: When you get the pain in a PDH, try to get the command as soon as possible. It will not reduce as of itself. Same holds for anaten command.

You know, for about ten minutes after receiving this, reading this, I did feel terror-- until I located the source, and blew it.

Then, on May 18, on same heading and signature, I received:

Dear Frank,

Under the CERTIFICATES MUST BE IN CLEAN HANDS PROJECT you are hereby ordered to come in to HCO for a full Johannesburg Security Check. If you refuse to do so your certificates will be cancelled.

I also warn you that what you have been printing is libellous and

unless you withdraw all accusations it will be turned over to an attorney for suit.

You can help yourself by cooperating in this.

In these letters, I am quite shocked. It is one thing to harass me personally. It is another thing to threaten to put before the courts, Time Magazine and all of the newspapers in the country a condition which I have revealed in Limited Editions of the 2nd Terminal. What would happen to all phases of Scientology then; Scientology as a science, Hubbardism, Hubbard & Co., and Hubbard's Witnesses? It would practically destroy them would it not?

I assure you that such is not my purpose. I am certain that there is nothing libellous in what I have printed. In order for there to be libel, there has to be a plaintiff. I certainly did not accuse Ron, or the official organization. But, to clear the records, I hereby withdraw any such accusations, if they are there. Let's keep it between us girls. My only purpose is to help people run out their PDHs.

Your over all policy and position is not clear to me. If PDHing is being done, it seems to me that you would be interested in finding out the details, so that the practice would be stopped. Instead you seem being in the role of the cop which Ron has talked about, who cudgels the citizen rather than showing any interest in finding the criminals.

Instead you have taken upon yourself to harass at least one other auditor who has done nothing more than to audit out PDHes. Why?

What is the crime? What have they done wrong?

Further, you have written similar letters to those whose only "crime" was to have their PDHes audited out.

Every one of the ones I know about were sent to franchised auditors who are graduates of recent ACCs. None of them are people I have audited on PDHs.

Lady, are you trying to set up a reign of terror? If you are, it will surely backfire. Do you think that you can keep the truth from Scientologists by the use of the bludgeon?

Some of these people are among the few who have already passed security checks.

Such frantic, irrational and violent action certainly precipitates a doubt relative to your intents and purposes. I feel that I would be very foolish to submit myself to this.

I feel that your own actions are more libelous than anything that I could say.

Some time ago, the Bill of Rights was published as an official Scientology document. I submit that this, particularly the sixth article holds just as well within Scientology operations as it does without. This article deals with the provision of the right of fair trial. You have indicted without specifically stating what the indictment is. Terror Stalks: I do not believe that Ron ever wrote that.

Marilynn, in spite of whatever it is that is influencing you, we are going to see to it that the Science of Scientology is a science of freedom of thought, freedom of speech. Too many people know about this now. The jig is up.

So, dear reader, where do you stand-- with terror or freedom?

The volume of correspondence has remained high. The general tone of it is to the effect that PDHes should be looked for and run out. Got two nasty post cards. One insisted that the overtil leader of the Marcap Group must have been my auditor. There is a sprinkling of those who have recovered PDHes on their own. Most of them are medium to highly complimentary.

Please be assured that as long as the present reign of terror persists, your letters, if printed in 2nd Terminal will not contain your name, nor will anything be printed which will indicate your identity. Even when you are working on your PDHes, do not bandy it about, unless you are prepared for harassment. Actually, there is not too much that they can do. They cannot "jerk" a certificate because you own it. You have earned it paid good money for it. It would be as ridiculous as, for example, the University of Michigan trying to "jerk" a Bachelor of Arts Degree. They do, however, have a perfect right to cancel franchises, HASI memberships. But, I have a good idea that this terror will not persist for long after Ron takes over again. But, unless someone robs my mailbox, your comms to me will be safe.

There are many interesting letters which I would like to print. But, a lot of these I have not even had a chance to reply to. Harold Ladas just about demanded that I print his three page typewritten letter in full. I do all of this work myself, an away from home, so I will summarize.

He checked Chuck Berner, and Chuck checked him for PDHs, found none, for this life. He mentioned some of the dub-in which could be confused with present life PDHes. He said That Julia Salmen had previously asked him to check for PDHes. Said that he likes the 2nd Terminal but is kept too busy keeping up with Ron's "procedure of the week" to use the processes. He got considerable benefit out of the 22nd ACC, is going to take the Special Events Course.

All has not been rosy-posy with me in the checking of PDHes. Biggest loss was an older woman who wanted hers checked, but after three days, the needle was still high, sluggish-- in spite of about 200 hours recently with another auditor. So we had to give it up, and she afterwards-- no drop on auditor at beginning of last session--got mighty mad at me.

I know that this is not the case with Chuck. It is probably more like the one I heard of recently in the east, where none was located. The preclear was not willing that one be found. Now then, from the tone of your letter, it does seem that the finding of a PDH administered in Washington would not be tolerable. Unless one is willing that it be found-- both the auditor and the preclear it is a no-session. This, of course, holds more for the auditor than it does for the preclear. We are now developing methods wherein it will come up regardless of prejudices. I will be happy to have a try at it, the next time I am in California.

So you were asked by org to check. It seems then that the CRIME is not to looking for them, but the finding of them. Good luck to you in Washington. But open your own "coke" bottles, make your own coffee, chew your own gum, and if someone jabs you, get out of there fast, and yell your head off while you have time. Keep your door locked, and let no one in at night.

Reports on the 22nd ACC are still far better than for any previous one.

A typical attitude is expressed from a person who has taken a course some time ago.

"Because when I lay down to take a nap, I was still "convinced" that the idea I might have been PDHed was "ridiculous;" now I have a sneaking hunch

something was a-foul... It won't hurt to find out that was it. Remember that I don't know anything yet; but I will look. If someone else on our course was PDHed I have a fair idea who. Pretty thoro job too-- more than one, I would say."

Yes, sometimes it is a lot casier to see it in others than it is in one's self. Good evidence would be a sudden change in attitude from being willing to look for one's self, to a sudden shift which might be obedience to any one or more of the PDH commands. A Thetan never switches from an attitude of independence, as outlined by Ron in Ability 90M to churchianity selflessness strictly on his own.

Thetans are not all equal. There are those who can but follow. No matter what was processed, they would not get far above that. But there are those who can run and fly. The knocking of these down to the churchianity level of Hubbard's Witnesses is what I object to.

The blackness that is PDHes, like all blackness, is put there as something to resist. It is regrettable that the mere bringing up of this subject will tend to sock this blackness in harder, on some cases. This is re-enforced by the repulsiveness of the whole idea. Further, the knowledge of the scores of overts brought to conscious level makes Scientologists motivator hungry. All of this adds to the difficulty in bringing PDHes to light.

All of them probably will not be lifted, ever. My consolation is that my buddies are those of higher Thetan capability, and in spite of all of this, they are now freeing themselves.
