VACUUM CLEANING PROCEDURE

Definition

This refers to the new process, "VACUUM CLEANING" and to the procedure of its use with other processes.

Scope

In quite a few articles in Second Terminal, the mention of the use of solids has been made. This is the major step made in the culmination of the putting of those theories into practice.

The basis of this procedure is that there is no evidence counter to the truth that, that which aberrates is contained within the solids of the bank, and that when the solids are removed, the aberration is removed. A consideration, postulate or opinion cannot possibly be aberrative as long as it is theta-determinedly created, is in no association with energy masses. That which is aberrative is that which is not-issued thru force, and is necessarily other-determined-- as per axiom 18, and others.

A datum in an energy mass is thereby hidden. When the energy is dissipated, and it is looked at, full understanding of it is then available. This is very new, and I do not know its limits. It bids fair to be the process for which we, as Scientologists have long been seeking.

As a dividend, it is no longer necessary to address PDHes as such. When addressed thru this procedure, they become easily available-- and with full certainty on the part of the preclear. You see, every PDH deposits an energy mass on the body-bank. As these are destroyed, the full content is revealed.

History

For the past few years, I have been experimenting with vacuums. I first found that by pushing in vacuums, energy sucking can be specifically remedied, and published this in the Second Terminal. I later found that by pushing in vacuums, the havingness of the Thetan is remedied, in the Complete Remedy of Havingness.

Then came the discovery of the odd phenomena, of "vacuums for." If you postulate the finding of a vacuum for blackness, say, push it in, then pull it out of an area-- it will be found to contain blackness when pulled out. When repeated, it will remove the blackness, totally, from the area, for example.

Next came the discovery that if a mockup-- including physical bodies, reactive banks, etc., is copied then unmocked; the unmocking causes a vacuum which, when pushed into the original and pulled out pulls with it, some of, or all of any other-determined energy masses which have been imposed upon that person.

It is interesting how I happened to get on to this. I had just finished an intensive for an old track buddy, who has been nearest to me, and we were just talking. Her big problem was an energy mass in and outside of the left of the face. It had been only alleviated by the intensive. I had had her mock up vacuums and push them into that area, but they came out clear.

Several months prior to this, I recovered that 13 trillion years ago, she had flopped to the black side, got mad at me, installed a curse consisting of my rock, a perfect cube-- with a silver blade stuck into it, on the top side. I sort of inspirationally-desperately had her mock this up, unmock it, push the space occupied by this mockup into the energy mass, and then pull it out.

It came out loaded with guck. We repeated it, and it still came out loaded. It became quite clear that we are herein dealing with something very fundamental. It is evident that there is herein a gradient which blends into the subject matter of Issue 25 Second Terminal, "The Entity Theory of Disease." Disease is totally psychosomatic. Somatics and aberration seem to be but another manifestation phase of the same thing. Theoretically, we should be able to just look at these things and understand them, blow them. But this is just something that lies ahead of us-- but I am certain that it is in the middle of the pathway not hidden in the underbrush of mechanics, figure-figure, significance processing, nor medicine.

Procedure Summary

From the above, this set of clues provided the basis for further investigation, which developed the data for this tentative procedure. It is issued a bit early-- as I feel that it is so important.

It consists of:

Finding Terminals

- Remedying scarcity-havingness on terminals, agree-disagree
- Running four way granting of beingness if not sufficiently solid
- Vacuum cleaning-- including time shifting
- Matched terminalling and grounding
- Getting commands--running agree-disagree on them

Finding Terminals

The terminal which will be most productive to run will be the one which when mocked up, and let go of, snaps in the fastest. For example, if the person who PDHed the preclear is sought, have him mock up those who could have done it. Select the terminal that snaps in the fastest without pushing. The fact that they snap in fast is not an index of whether this person PDHed him, as there may be other insidious occurrences on the track which may have caused him to not-iss this person-- with the scarcity of him resultant. Terminals could be places, things, as well as people.

Remedying Havingness

When the terminal is established, have preclear continue to mock it up and let it snap in. Time is saved if the preclear can avalanche them, that is mock them up in huge quantities from all sides and let them snap in. He can usually mock them up faster than the command is given. Allow him to do so, if he can, with certainty.

Anytime in any other part of the procedure, if the mockup gets faint, have him again remedy havingness.

It is certainly in order to have him continue pushing them in, until the remedy is complete. The terminal is workable, however, if they no longer snap in.

Four Way Granting of Beingness

This is fully discussed in Issue 20, pp.7, if you can read it, reprinted in issue 21, pp. 4.

It is usually when there is an overt act committed against person that the preclear tends to not-iss him. To put him into full reality, run:

"You tell _____ 'YOU ARE.'"

"You have _____ tell you 'I AM.'"

"You have _____ tell you 'YOU ARE.'"

"You tell _____ 'I AM.'"

Place the emphasis on the capitalized words to properly convey the meaning of the command.

Agree- Disagree

This is the specific for hypnosis.

Hypnosis IS an enforced flow from the hypnotist to the victim. The presence of flows is not always discernible to everyone, as Ron has pointed out in R2-54, "Creation of Human Ability." But, this is not the case when hypnosis is contacted.

The rehabilitation of the ability to agree with and to disagree with the hypnotist, on one's own Theta-Determinism is the frontal attack on the hypnosis. As long as the flow is an outflow, in disagreement, it is still in resistance to the command, or the person. Therefore, it is processed until the preclear is above flows. This is done by having him do it more and more rapidly, until they merge into one. At this point he can then CREATE his own agreement and disagreement.

The command is simply:

"Agree with _____."

"Disagree with _____." Run alternately.

Then after the flow is running well:

"Agree with _____ and you create the inflow."

"Disagree with _____ and you create the outflow." Run alternately.

Then speed it up, as he takes control. Acknowledge only sparingly in order to save time. Run faster and faster-- then have him do it himself, running it still faster, until they merge, as above.

(Did it ever occur to you as odd that org Sen. has never allowed Ron to give you a command which counters hypnosis?)

Vacuum Cleaning

After the terminal has been made REAL, we are ready for our piece de resistance.

The commands are:

"Mock up _____."

"Unmock _____"

"Push in the space of the mockup." (Actually it will snap in.)

"Where did it go?"

"Pull that space out of that body."

"How does that space seem to you now?"

If he gets something in the space, ask him. "What does it seem to be telling you?" If he gets a command, run agree, disagree on the command, then double terminal it, as below.

Grounding Matched Terminals

This is discussed in Issue 20, Second Terminal. I have been using this for over a year now, as have others, and it is MOST EFFECTIVE as a means of removing other-determined solids from the bank. By other determined solids, I mean those which are held in place by our own force, not by our own agreement. It has been definitely determined that those forgetter mechanisms, etc

which we agreed to, in a games condition, simply will not reduce. Others, when run are gone; and man, when I say gone, I mean GONE. This is in contrast to figure-figure processing, wherein one "Thinks of," or "gets the idea of," merely pushes it away-- ready to be keyed in again, when a similar stimulus occurs. Any so-called clearing that has been done, has been on this temporary basis. Now, really-- they have been temporary, haven't they? Is there any radical change in the present "processes of the week" which would indicate, as they are now AGAIN(?) making clears, that these so-called clears will be otherwise. But-- keep coming and coming-- like the PDHes tell you to.

The commands are:

"Select a spot, and at that spot, create a white tube of energy, deep into the earth." (If you are auditing in a city, have the PC locate it in some unoccupied place, in a park, better, out in the country-- if he can. Best, is out on the western desert.)

"Mockup _____ twice above the tube."

"Create a line of white energy between the two mockups."

Ask about how it is going, often-- especially at first. If the mockups fade, complete the cycle, then go back to havingness. Most often the line will really spark, may be hard to control-- but have him continue.

"Tell me when the line has simmered down."

"Create a line from the center of this line, into the tube."

When this happens the mockups will fly to the center of the line, follow the new one down the tube, and explode.

If this does not happen 100%, there is usually too much charge on it and it should be repeated. If there is still trouble, there is usually a major consideration which has not come out. Ask for it, get it and repeat. (Commands can be abbreviated, as preclear gets hep.)

Considerations, Postulates and Opinions

Generally speaking, it will not be necessary to ask the preclear for data. As these solids get all shook up, the considerations, postulates, opinions, commands, identities, etc. fall right out. The tough part is to keep him from spending valuable time trying to get the significances out of them.

Each ridge, for example, contains hundreds of facsimiles, and each other energy mass, whether it is a PDH, a witches' curse, a tight control mechanism or what has similar interesting by ways. Do nothing to stop him from getting solid reality upon what he is doing-- but, outside of this, keep right on going. In this you are DOING something, not just talking about it, philosophizing.

Matched Terminalling, grounding machines, etc.

When an energy mass or a machine appears, the auditor may find it most effective to matched terminal and ground the original with a copy, rather than making two copies at another location. Of course, if it is a machine which will easily succumb, one of those which are easily found just by looking for them-- and are not particularly aberrative, as referred to in R1-14 Creation of Human ability, they could be just copied and reduced. But, you will find that just about everything that comes up in this processing is big league stuff, and just copying them only makes them more solid.

So, have the preclear matched terminal and ground it, right in the room. Some things will not budge, otherwise. Use the thing itself as one terminal, copy it, and proceed.

Heavy Commands

If the commands are extremely heavy, and the preclear has difficulty handling them with straight agree-disagree, have him exteriorize the command by having one large object in the room giving it to another one.

For example:

"Get the idea of that desk telling that bookcase(repeat command).

"Be the bookcase, and agree."

"Be the bookcase and disagree."

Run the whole agree-disagree sequence in this manner.

Then repeat, with him being cause, being the desk.

Then have him run it subjectively, check to see if it is reducing.

If not repeat.

How long do you run it? How high is up? Just try it and let me know. I ran my last preclear's PDHes without even asking for them. If it is invalidating, negative commands that hold up the case, this is what will come up. If one process bogs, run another one, and come back to it.

"TERROR TALKS"

There is one very accurate piece of data in that article-- the only one to make Ability, HCO Bulletin and PAB. The screaming was done when Ron presented the truth to the world. Boy, they were scared. How come there has not been any since that time? The only reaction that I know of in U.S.A. was the raiding of Refa's Dianetics Center in Detroit in 1953...until just now, as below. Quite a co-incidence that she happened to be the one who called my attention to PDHes in the first place. Because of the known connection between PDHes and the death of her husband, she is a bit more acid about the matter than most of us, is not longer in Scn. I am a Scientologist, in no way associated with her group. Another good field terminal down the drain.

Yesterday, I received the following from a practicing scientologist who had previously written that he had uncovered D.C. PDHes prior to the issuance of 29A.

... I've been looking at implants here & one P.C. spun in completely. Then the following night I felt a very heavy bank. My auditor checked on implants. I exteriorized and saw this "being" in the room. He was the strongest I have ever seen. He'd had me not-issing him. When I saw him, he was shaped like a "bust." He then disappeared and I "heard" him say he was going to get help. The gal (who went psycho the next day) had been in the implant game here in some fashion. I told her about it(as-ised her game) she sneezed several times. 2 days later 2 plainclothesmen arrested me and took all of my preclear's data and my e-meter.(illegally) Booked me for no license(business) using my preclear's goals to intimidate my P.C.s. Said that drugs are the total endeavor of Scientology-- that we are commies, etc. etc.(Boy, did he ever go get help.) ... Every scientologist in this area is in jeopardy as to his beingness. The P.Dept.(pain drive) is contacting all PCs and Scns. & told them not to audit, or else! As it stand now I am going to find out when trial is next week . I'm wondering if this is an international cave, or just local. Julia Salmen, H.C.O. is going to help, too. I have an attorney, but I feel he may be implanted too. It's a very big game for him to play.

So, the only harassing that has been done in these United States has been done to one who has been running PDHes and implants! Could it be that "they" thought that they were safe when they took over Ron?

Note the similarity of accusation which is found in above, to the irresponsible derogations found in Issue 129 Ability (which just arrived as I am cutting this stencil.) I say irresponsible because it bears not the slightest evidence of the hint of truth in the wild statements. If a vulgar person does not like you, he calls you a S---- Bi----. Slightly less vulgar people will call you a conmie. Actually, a couple of weeks ago, I got the idea that maybe a lot of these so-called conmies were not such at all. Maybe they had just been PDHed. So I wrote an FBI agent friend I had known for about 30 years, explaining what I have been doing, and asking if there was any application. Had a nice, long talk with him today. Do not know for sure if anything will come of it or not. Has to go thru channels, etc.

Let's get back to this guy with troubles. No use keeping this a secret, especially when he needs help. He is Frank Metcalf, HCA (I think) of Eureka Calif. But, address him at 7248 Calder Ave. Sebastopol Calif. He has notified west coast HCO office. Hope that he gets more help than we did in Detroit. We had the same trouble with attorneys, then.

Actually, that area Frank has been working in appears very black, when regarded thetawise. Funny things like that happen in these areas. I feel sure that otherwise, there would have been no trouble. No one else has had any. There is sure "something" that DOES NOT WANT PDHes, IMPLANTS RUN OUT.

You know, I do not believe that that silly babble in issue 129 Ability sounds very convincing to these who have experienced the anaten, the elsewhere-ness, and the agony of the PDHes they have run... or are running. Again, if these are wrong-- everything we have been doing in Scientology is wrong. I have yet to ask for a PDH and gotten it; usually a null answer. This may be different, tho, if I had asked a PDHer, tho. But, we now have a new definition of a squirrel: A franchised D. Scn. running out a PDE. What is more, there are quite a few doing it.

I'M STILL WITH RON

All of this looks as if I have a big squabble with Ron. Heck NO!!! Do I have a squabble with Dr. L. Ron Hubbard? Heck YES!!! When we ran responsibility processing, our different identities somewhat revealed themselves. There is ourselves as our lowest individuation. That is us as our present life identification. Our past identities had available more knowingness, general ability. Every bit of processing I have done has been in the direction of assisting the preclear to recover these past identities-- and the games they played at that time, that these abilities might then be recovered. It is the only way I have found to regain them-- because if we feel that it is dangerous to be these higher ability personalities, it is also dangerous to have the abilities we had at that time.

Anyhow... We all have within us the potentialities of regaining these higher personality characteristics. THE ONLY WAY THAT THE BEAUTIFUL TRUTHS OF SCIENTOLOGY HAVE BEEN REVEALED TO US IS THAT, SOMEHOW OR OTHER, RON AS HIS HIGHEST ORDER OF BEINGNESS WAS ABLE TO BYPASS THE LOWER PERSONALITY TO REVEAL THEM TO US. There is nothing that could happen which would in any way alter the almost reverent affection which I still hold for this beautiful beingness. I can well recall how I felt when I first entered Scientology.

I was just a body. I was trained to be an industrial engineer, but had not real liking for it. Sure, I had just founded Southern Michigan Iris Society, was Secretary of the local Kiwanis Club. But, in the main, I was just a nice greying gnetleman letting the years drift by to a nonotonous old age. I was damned uncomfortable. Somehow, I knew that there was something better-- but what?

In the late forties, there was a young girl staying with us, who had had a most unfortunate early childhood, was undergoing considerable emotional disturbance, kleptomania, etc. She was put under the care of a psychiatrist.

One day the head shrinker called me in, told me that she was inaccessible that there was no point in continuing the treatments. On the way home, I asked her how she like this psychiatry stuff. She said that she thought that it was interesting. I had a couple of books home on the subject, and asked her if she thought it would be fun if we would read them together. She said that she did. We did. She would read for a while, then I would read. Importantly, we would discuss them in between. Know what happened? She got well! I did not fully realize just what it was-- but, for the first time in her life, I had gotten that girl into communication. Actually, I was in no better shape than she was in-- just had things balanced somewhat. I strongly felt, "My God-- there MUST be an answer, somewhere!"

In July 1950, my dentist, who knew all about this, mentioned that another dentist was experimenting with a subject called Dianotics. I left his office, drove six miles out of my way, got the book. It sure did not take me long to realize after starting to read it, that THIS IS THE ANSWER. I became the leader of the first Dianotics group in Detroit, which I surrendered when Refa and Olla Currie started the Center here.

ORG DETERMINISM VS THETA DETERMINISM

I honestly feel that I have derived more benefit from Scientology than any person I know of. I am fully cognizant of the fact that if it were not for Ron, and the wonderful teachings he has given to us, I would still be nothing more than a body growing older every day, still feeling that surely there must be something better.

But, on the other hand, I still remember that my case did not really move until I disidentified myself from org, really started looking and evaluating for myself. It was at this point that I founded the Second Terminal-- in the hope of inspiring others to do likewise.

IDENTIFICATION VS THETAN PROCESSING

For year after year I have listened to newer and newer "clearing" techniques, and other processes designed to polish up the present life Identity. Nothing from org in any way assisted us to gain the reality of our true beingness. Scientology had become, as Dr. L. Ron Hubbard put it, 19th ACC, "Preactical." It had degenerated to a Hubbadian Psycho-therapy-- and the resultant has been greater this life comfort, and the identity becoming more and more tractable, controllable-- by org. Now then, this is wonderful for the average guy walking down the street. But, this was being done to those Thetans who are capable of better things-- who are capable of knowing and doing for themselves, without enforced dependency upon org. I revulsed at this.

Everything I have done and have written has been to the purpose of assisting others to know themselves and to become themselves as their higher identities. This goal has been achieved in practically every intensive I have given... except the one which is to me the most important one. My goal is a democracy of Thetans, which is versus the present dictatorship-- with all Thetans convinced that they can do nothing as of themselves, but can only submit to the other-determinism of a black few which have enslaved Ron, and are capable of communication only with blatant derision.

Ron, as he has often told us, but not lately, is operating at many levels, (Issue 28). The dramatis personae: Ron the high beingness in conn with Theta-- who has given us the trues of Scientology. Hubbard, the identity which is playing the game of Hubbadian Psycho-therapy. L. Ron Hubbard, entrepreneur of Hubbard & Co., which is making Scientology solid. Dr. L. Ron Hubbard, the idolized image of Hubbard's Witnesses. References have been, and will be made on this basis

My goals continue to be to practice Scientology as it has been originally presented to us by the highest order of beingness which has visited this planet in milleniums. The PDH, the implant, other interferences with Theta-determinism will be reduced. Org processes have been tailored to eliminate any processes which are apt to turn them up. Is this the comic line? It is either the comic line-- or you have been intentionally deceived betrayed by those in whom you have placed your full trust. Look. See for yourself.

FREEDOM PROCESSING

This process, developed by Charles Phillips, and used at the Church of American Science, Berkley, Mich., brings PDHes and implants to light without addressing them. The commands:

"What can you be free on?"--("in the past can you be free on?")

"Can you be free not to?"

"Can you allow me(others, specific people, etc) the same freedom?"

There are many variations, brackets, etc. More on this later.

Mockup Shifting(My goof, should be after "Finding Terminals, pp. 2)

Have preclear mockup, say, a hypnotist. Use any valence, or anything that should be run.

"Unnock _____ and find the space it occupied."

"Allow to come into that space, whatever comes:"

If it is a present lifetime personality-- "Allow time to shift."

"Allow to come into that space whatever comes."

Whatever it is that is most aberrative, and can be handled at that time, is what will appear. If it is, say, the present life father-- the same Thetan in a past body, which was aberrative, is what will appear. If "Hypnotist" is used, the PDHer, will probably appear. It will usually be the one who did it. If it is the one the PDHer said did it, it will, of course, not run.

Remember: you own your degrees. You paid for them. They are irrevokalv able, just as any other degree issued by any other school is irrevokable.
