For quite a while, now, my Huborg Scientology friends have pestered me to get some of the "lastest." I took a look at what I was doing, the results I was getting, took a look at them, and the results that they were getting, and sort of shrugged it off. Well, a couple of weeks ago, I found my needle at over 4.0, for several days in a row, and not very clean. So, I contacted a Huborg franchised auditor, a 2 goal plus, clear-- 3rd goal found, partly run. Let us say, a 2 37/64 goal clear, and made arrangements.

Well, last December, Tuc Farrel collared me in N.Y., ran R212 for a couple of hours or so. This session was run on the Huborg list, like Ron, Mary Sue, various Scn. hats, etc. Everything flattened on the second pass thru, excepting "courses" and "Scientology organization." They flattened the third time thru. Then I got "tigerea" on whos and whats, including the wildest past track stuff I could imagine. Everything folded up pronto.

The auditor this week ran a much longer list. Oh, incidently, my needle went back to 3.0, the day after I made the arrangements. My needle has been clean at 3.0 95% of the time for the past five or six years. Well, anyhow, nothing to bite was found in the entire list. So then something with a real short name like Minnesota Mining and Manufacturing was used.

I understand I got a lot of small ticks on quite a few things, but each flattened on the second command. It seemed so futile. Thereupon, I violated the preclear's code. I felt sympathy for the auditor. So, I decided to take a look thetwise and actually see what was happening. The next time the auditor said, "That read," or "that reads," I took a look thetawise. I saw a tiny chunk of bank there... like a worm with a tail on each end. I pulled my attention away from it-- no read. I put it back on it-- read. Instead of helping the auditor, I guess I further disturbed the auditor. So I told what happened. I then exploded the cute little wiggly mass-- no more reads.

Later, I found one that had a series of bumps on it. I touched each bump, like running your hand down a venetian blind, tic.tic.tic.tic-- and the auditor responded. that, that, that, that. Fun-- for me-- but not the auditor. And the worst was yet to come. Started looking for goals.

Somehow, the word "creation" got into the act, and fireworks. Now then, when I was run on the list used about the time of the Joburg inquisition, this same word, "creation" was the biggest register. Anyhow, when this came up, I got an uncontrolled repetitive rocket read, which persisted, no matter what else was done.

I even felt uncomfortable. I was touchy, tho. Seemed to me the auditor was like a robot. Questions like, "Is there anything you have failed to reveal that happened since-----" But, even right now, I do not like that. When they ask, "Is there anything you would like to mention---" I will go along with them.

I cognited-- and I understand, it read-- that the right phrase was, "win Creations." Just what this means, I did not, and still do not know. I looked around me, found other small masses, completely cleared an area for about ten feet all around me. But, still this rocket read persisted.

I knew something was there, and it seemed to be intentionally hiding from me. Finally, I found it. It was right in the middle of the space of my head. It had a sort of inverted teardrop shape, like the universe body I have referred to in past issues. It was a dark, slate color, and sort of polished. I have been looking at GPMs for some time now. The ones I had seen before had a bunch of wiggly wires and masses sticking out from them.

In research, I have asked the preclear to mock up a black mass, and postulate that it contained the first available GPM. (Goalsproblem mass) I then asked him to run a line from the mockup to his body or bank. Invariably, it connected itself to a tangled mass. We copied it, unmocked the copy, pushed the space, or vacuum of the copy thru the original, reduced the solids, cleaned up the void. Preclear experienced more discomfort in running this than on most other subject matter, but the average time of running so far is 50 minutes. The preclear always felt better afterwards.

Yeah, and I feel better after reducing the mass in my head. It was tested, and there was no reaction whatsoever, after vacuum cleaning it out, on either the goal "to create" or the goal, "winning creations." I have recently recovered an ability to actually play, as improvisation, most any melody which goes thru my mind. I have long since been able to mock up and hear complete sonatas, symphonies, but could not actually play them. I have tape recorded some, and people seem to like them. But my playing has not been good-- like, no one ever asks me to play at parties! I had tape recorded some of my playing of popular type music, and this morning, did the same. There is a vast difference, since this auditing. My ability to create improvisations has not been effected.

So-- what is herein indicated? It points to the most likely possibility that goals, GPMs can be run out, by a lot of people by any auditor who can run the simple Vacuum Cleaning Procedures, and can do it in a small fraction of the time-- without the months of suffering, and the expense of St. Hill.

Most importantly, the running of Vacuum Cleaning Procedure has NO LIABILITIES. That is because you work directly with the solids, not the significances. If an auditor makes the mistake of running the wrong terminal, in Class 4 goals running, this adds an alter-ness mass, or makes the original correct mass more keyed-in, or sensitive. If the wrong mass should be addressed in Vacuum Cleaning Procedure, there will be no effect. It just means that the mass does not have to be addressed later. So, try again. No harm done.

Also, all banks are different. R212 etc. does to some extent align them, by consolidating goals-problems-masses. But, the degree of entanglement is quite variable. When this occurs, and/or two or more seek to emerge simultaneously, we have complications which seem to account for the many failures encountered in running them using Huborg processes, alone. Such complications have not yet proved bothersome, in running Vacuum Cleaning Procedures. As we deal only with the solids, whatever is addressed is removed-- and whether it be totally or partially is just that much gained, and so-called "flattening" is not required in order to make the preclear feel comfortable.

Those who have had Vacuum Cleaning Procedure run on them do marvelously well in Goals, GPM processing in Huborg. It is my feeling that these should be combined:

1. Locate the goals, using Route 212, etc.
2. Run the goals out using Vacuum Cleaning Procedure.

This proposal is, of course, limited to those who can make mockups. If you can mock up, I stand ready to work with you on this. The running of Vac-

uum Cleaning Procedure, also, does not produce ARC breaks, or, as mentioned, discomfort on the part of the preclear. I feel sure that any auditor who has mastered the comm course, certainly gone thru HCA, can do it. But, the auditor who can see banks certainly would be doing a lot better. I feel that this lookingness ability-- which can be developed-- is a far greater asset to an auditor than mechanical perfection. I know of quite a few Thetans who could do this right now.... Maybe you can, too.

I stand ready to co-operate on this, either within, or without Huborg.

There is much more to the bank than just GPMs. Others, and I, who look, know this, can see this.

THETAN PROCESSING VS MECHANICAL PROCESSING

Ron has long since told us that anything that can be done by mechanics, a Thetan can do better. So it is with auditing. Goals processing is a mechanical process dealing with the most mechanical part of the reactive mind-- the somatic mind. Truth is simple; but mechanics and aberration are most complex. The somatic mind keys in with words. How it shifts with language variations with each lifetime is not clear. It is indicated that a lot of word roots go back to Atlantus, other past civilizations. Really, goals processing is just expanded Dianetics, not Scientology, at all. It painfully sorts out the garbage, puts the tomato peelings, the coffee grounds, etc. in a nice pile-- instead of taking the crap as it comes and getting rid of it, quickly, easily painlessly. I agree that running this out of the somatic strip should be done. I do not agree that even completely reducing it, with maybe the hundreds of goals contained therein will produce anything more than a cleared somatic strip.

As long as the being would keep his awareness only on this life realities; as long as he does not seek anything beyond it-- does not question any of his past "agreements" resists past implants-- he will be comfortable, controllable and happy.

But, the Thetan is not only a somatic strip. He just uses the somatic mind to allow himself to be squeezed into the black boxes, limited spaces of body games in individual bodytimes.

A person "clearing" who had run out all of these GPMs would have no more Thetan ability than he had when he started. The ability is already there. He would have, however, avoided ONE OF THE MANY obstacles to BEING as himself. As Hubbard says, there is no thing as one shot clear. True, and there is no thing as a one shotclear process... including Vacuum Cleaning Procedure.

The Thetan has many other areas of reactivity, other than those in the somatic mind. How do I know this? I have looked and I have found them. Many others have looked and found them. Each seems to be in a different "universe" in that many of them occupy the same space. Implants are real. They are there. They restrict the abilities of the Thetan. Other agreements, as outlined in Issue #41 2nd Terminal debilitate the Thetan. Past valences aberrate us. These and others are addressed and reduced using Vacuum Cleaning Procedure. They remain intact for the "goals clear," tho they may be temporarily keyed out.

Goals processing is mechanics, done by mechanically skillful auditors. Vacuum Cleaning Procedure is GRADIENT THETAN OPERATION, and is accomplished thru Thetan doingness.

My definition of a Theta Clear: A being having no aberration other than that of being a viewpoint.

My definition of an Operating Thetan: A being having no aberration other than that of being a viewpoint.

Those definitions are obviously absolutes. They can be approached only gradiently. They can be gradiently attained by ADDRESSING ALL THAT RESTRICTS THE ABILITIES OF THE THETAN, ALL THAT CAUSES HIM TO CONSIDER HIMSELF TO BE SOMETHING LESS THAN HE REALLY IS. These somethingnesses are ALL of the content of the bank. If you ask him, he will bring up that which is to be most optimally addressed.

This is done by gradiently taking one's viewpoint as a Thetan, becoming, as Ron has said, "familiar" with that viewpoint. It is far better to reduce the somatic mind, assuming the viewpoint of the Thetan than it is interiorizing into the mechanics of the somatic mind. Mechanics cannot eliminate mechanics. It can but key it out. The Thetan can erase mechanics. Vacuum Cleaning Procedure handles the somatic mind, and all other parts of the bank from the viewpoint of the Thetan, effects total erasure. Long and painful Goals Processing merely keys a selected and limited portion of it, out.

How do I know all of this? Because others and I have LOOKED and seen what is transpiring. We have researched sufficiently to validate what we have seen and KNOW to be true. We have LOOKED thetewise, and have researched MESTwise. To the dialectic materialist, any Thetan awareness counter to present agreement is "hallucinatory insanity". To the dedicated souls in Huborg, any lookingness counter to their catechism, is "bank reaction." This is the essence of non-granting of beingness.

BUT. PLEASE UNDERSTAND THAT THE ABOVE-- AND ANYTHING AND EVERYTHING ELSE I HAVE WRITTEN IN THE SECOND TERMINAL DOES NOT REPRESENT AN ADAMANT, FIXED VIEWPOINT. I AM WILLING TO CHANGE MY ATTITUDE AND COURSE AT ANY MOMENT. SO, IT WOULD BE INEXPEDIENT TO FIX A DEPENDENCY UPON ME OR WHAT I NOW SAY. I SAY THIS IN SPITE OF THE FACT THAT I BELIEVE THAT I OPERATE ON THE FIRM STABLE DATUM-- I AM. ALL OTHER DATA IS ACCEPTABLE IN MY GAMES UNIVERSE ONLY TO THE DEGREE THAT IT ALIGNS TO THIS STABLE DATUM. SOMETHINGNESSES ARE BUT TOYS TO BE PLAYED WITH-- INCLUDING ORGANIZATIONS. BUT AS FOR YOU AND YOU AND YOU, I VOW TO GRANT YOU FULL BEINGNESS AS WHAT YOU SAY THAT YOU ARE.

I AM PERFECTLY WILLING TO BE WRONG. THAT IS FUN, TOO. WHEN IT IS EVIDENCED THAT I AM WRONG, I WILL GLADLY SAY SO.

NO STABLE DATUM..... SINGLE STABLE DATUM..... RANDOMITY

Counter to the above, it is recognized that the achievement of Theta-Determinism is gradient.

Most people enter Scientology because they ARE Thetans of a high potential Theta-Determinism. As Ron has said, and as is my own reality, Thetans are of NOT equal endowment.

But, regardless of potential, those who first enter Scientology are lacking in a stable datum. They are seeking an ACCEPTABLE single stable datum to which other data-- as acceptable --- may be aligned. These people are not capable of much randomness at this point. They are seeking a singularity of certainty. Huborg provides the impact, solidity therein optimum. It gives it a stability, something like ambergris does in a perfume. A good solid bridge is necessary en route from no stable datum to the beginnings of Theta-Determinism.

This solid bridge must be of MEST content, follow MEST laws. Many such bridges have been built by great teachers, and the followers of great teachers in the past. In each and every case, as the number of adherents increased, the leader(s) became more and more interested in the perpetuation of the organization, and in an effort to make it more universally

appealing, more and more deviant from the original goals. Heavier and heavier controls are installed. Anything not originating from the sacred source is to be considered "bad." They preach one thing, practice another-- and the deadi-cated adherents do not notice this.

Does that make the great leader(s) bad? Hell No!! He, I, or anyone else can give you freedom and Theta-Determinism. Goals Processing, Vacuum Cleaning Procedure, or any other processes cannot give it to you. They can assist in removing obstacles which obstruct your creativity, power of choice, creation and execution of YOUR OWN start-change-stop cycles of action.

The white side mystics tell us, "No one can really help you (or at least they do not know how) you alone must do it." So, they meditate, regard their navel, interiorize into their religious implantations.

The black side religious method is, "Trust in us, have faith in us; do as we say." We have the only pipeline to _____ (wherever they say they are going). We, alone are the only possessors of truth. Have faith in us (or play our game) and you will automatically be free." And so, they get "forever" stuck in the religious organization.

Just like any other black-white dichotomy, each contains one-half of the truth. If you are lacking in a single stable datum-- feel lost-- my opinion is that the best thing for you to do is to go to Los Angeles/Washington and take a course-- or at least find the nearest Scientology Center and start from there.

But, the rigorous trials and tribulations could be fun, if you got your Thetan tongue in your Thetan cheek and KNOW that Huborg association is a means to an end, not an end in itself. You will see some "deadi-cated souls" who seem sort of stuck that way. Well, maybe they are just temporarily stuck in a religious implant, and next week will break loose, start kicking up their heels, and cavorting over the meadow. Then, there may be some who may be of less Thetan endowment whose ability to be really Theta-Determined is relatively more limited. These are also being helped as they may be working at somewhere near their top potential. "Had" and "must be contributed to" is not the lowest level on the scale.

I have ceased to worry about able Thetans being trapped for too long in Huborg. When they are ready to start playing their own game instead of Hubbard's game, they will. Yep, and that is wherein the fun begins. Here is a book I recommend:

Doubleday ordered mine, but, I believe that any book store will do this. It is a delightful, light story about a monkey who decided that he was going to better himself spiritually. He does so really having a great time of it overcoming obstacles, twitting authority, getting clobbered. I really like that little guy. Oh yeah-- at the end, he attains the state of Bodhi.

Does it seem sort of funny, having me telling in these here pages that they should go to Washington, etc.? Well, I do a lot of perovading, and I really think it is getting better. Almost every change they have made-- for a change-- I like... Like the comm course, TRs. There are other things. I knew Mike Moran in Phoenix-- saw him again after his HCA. Never liked John Farrel until just lately, etc.

I fully recognize that problem Ron has been facing these years, regarding destructiveness. The shift from bank determinism to Theta-Determinism is

not instantaneous. Morals, mores are essential, in order to keep banks under control. A Thetan IS ethics, and true Thetan Determinism is never than other than on an ethical basis. But, should Thetan abilities emerge prior to Thetan Determinism, a destructive band is likely to be encountered. It is well and proper that the Thetan fledgling have an other-determined control, until this band is traversed.

Altho, I believe that the above holds, I still do believe that too heavy a hand has been lowered in the past. I hope that the relaxing which seems to have taken place lately is based upon this realization.

Further, I reserve the right to change my mind, attitude at any time. Things were pretty good in Washington just before Dick Steves left, and I wrote up a complimentary article about it in an early issue of 2nd Terminal. Same holds true, based upon what I saw in Los Angeles, later. As far as I am concerned, they will still hold the burden of proof.

I am not in accord with sending emissaries around the country talking against income taxes, while at the same time planning on levying 50% income taxes on auditors within 50 miles of a center. Nor do I like slandering doctors, when the medical profession allows complete freedom of individuality and movement, fees charged, etc. Seems to me that Huborg is herein incorporating the worst elements they can find in both communism and capitalism-- both of which they resist so strongly.

Amnesty-- as "granted" by Hubbard to all, is a two way flow, I it not unilateral. It is bilateral.

I stand ready to co-operate with, "grant" amnesty to any Hubbard Organization, provided I am not asked to disparage my own strength and power, disparage my realities, or in any other way depredate my Theta-Determinism. I intend to be my own adviser, keep my own counsel and select my own decisions. I intend to adhere to, and expect them to adhere to everything that has been printed in the best Ability so far printed, #147.

In this, it will be, perhaps, a bit difficult to close terminals tightly with those who are still seeking a solid stable datum to cling to. Perhaps, with-- which I prefer-- or without Ron's blessing, a separate order of Scientists, collaborating as closely with the main group, as Hubbard would allow, or could tolerate. Perhaps he might continue his past policy-- which is so utterly inconsistent with contents of Issue #147-- and give this a great big frown. If he continues to insist that Scientology is "Ron's game" that everyone else is a piece, no dice. The others I am pretty much speaking for, and myself are happy to operate on the level of "contribute to" are totally unwilling to operate on the level of "must contribute to."

ISSUE #147 of ABILITY

A number of points have been brought out in "How to Study Scientology" pp. XII. I will bring some of these out, individually. Summarized:re-read them

Point 1. (pp.XII) Find out for yourself if it works. Should have said: find out if it works or not. Good point, tho. Do not use a useless process merely because it is authorized. I reserve the right to decide for myself whether or not the process is helping the preclear to be what he wants to be. If it is just making him more comfortable, I feel that it is useless.

Point 2. (pp.XII,XIII) Authority is generally the basis of agreement, sanity, etc. Within Scientology, this is: "Does Dr. L. Ron Hubbard agree with your proposition? No? Then, of course, it cannot be true. Dr. L. Ron Hubbard is an eminent authority in the field." Have you ever felt this way as you read the Second Terminal? Have you ever felt, "Vacuum Cleaning Proced-

ure cannot work, as Dr. L. Ron Hubbard does not agree with this proposition. Then, of course, it cannot be true. Dr. L. Ron Hubbard is the ONLY authority in the field.

Point 3 (XIII) "I would rather err with Galen than be right with Harvey." I ask you: How many Huborgians feel, "I would rather err with Hubbard than be right with Sullivan."? It is not a matter of who happened to be right Hubbard or Sullivan if these Huborgians feel this way, it just ain't scientific. The guy who comes up with something different really gets it. Medicine fought Freud; Freudians fought/ignored Hubbard; Hubbardians fought/ignored Sullivan.

Now then, if someone in Scientology really practiced what Ron herein preaches-- what would Ron do? If I were Ron, I would ignore them. But, I would hope that the guy would put up enough assertiveness to really make himself real. Then, what would I do? Well---- that depends on what I might think would be the most fun to do at that particular moment.
